***Direct Members...****This category includes the country grain elevator companies, feed and flour milling operations and export grain merchandising firms throughout the Pacific Northwest. Direct members are assessed annual membership dues based on the company's gross annual sales volume. The Association's dues structure was created by the Board of Directors and is subject to periodic review as budget conditions require:*
